Promotion of Officials in IRCC

2095. SHRI GANDHI AZAD: SHRI R.N. ARYA:

Will the Minister of SURFACE TRANSPORT be pleased to state:

(a) whether Managers (Pers.) vacancies were available in I.R.C.C. during 1991—93, two each in the market/departmental quota;

- (b) whether nearly 70 employees promoted without vacancies during 1991-93 in different cadre except from Deputy Managers (Pers.); to Managers (Pers.);
- (c) if so, the details thereof indicating rules under which these promotions were made and those denied in other cadres even though vacancies were available:
- (d) by when Government propose to promote Deputy Managers (Pers.) to remove their long standing grievances; and
- (e) the reasons for not imposing winding up condition for other promotions also?

THE MINISTER OF STATE IN THE MINISTRY OF SURFACE TRANSPORT (DR. DEBENDRA PRADHAN): (a) to (c) 112 promotions were made in IRCC during 1991—93. All these promotions were reviewed as per the sanctioned strength and vacancy position and approved by the Board of Directors on 18th December, 1997 which is the Competent Authority. Two vacancies of Manager (Personnel) were available against market quota after these promotions. No constitution of DPC was considered necessary to fill up the vacancies of Manager (Personnel) as per the decision of the Management during 1991—93.

(d) and (e) Board of Directors in their meeting held on 18th December, 1997 had decided not give any further promotions to IRCC employees till further orders. Government has since decided on 1.2.2000 to wind up the corporation. The question of considering any promotion in the Corporation at this stage does not arise.
