

(c) and (d) Yes, Sir. Proper utilization of funds by NGOs is ensured through regular inspections by the concerned State Govt., officers of the Ministry and the designated Nodal Agencies. Besides, the NGOs, are also required to submit periodic progress report, Audited Annual Accounts and Utilisation Certificate duly certified by a Chartered Accountant for grant released during the previous year.
