LPG Agencies and Petrol Pump in NER

2400. SHRI PRAKANTA WARISA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) the locations in the States of NER, particularly in the North Cachar Hills District of Assam where LPG agencies and petrol pumps have been allotted during the last five years; and
- (b) the time by which more LPG agencies and petrol pumps are likely to be set up in the country during the next five years, state-wise?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI E. PONNUSWAMY): (a) During the period 1994-95, 1995-96, 1996-97, 1997-98, 1998-99 and 1999-2000 (April, 99 to February, 2000) a total of 51 retail outlet dealerships and 76 LPG distributorships were allotted in North Eastern States. No retail outlet dealership or LPG distributorship was allotted in North Cachar Hills district of Assam during the period.

(b) In addition to the locations pending from previous Marketing Plans 927 retail outlet dealerships and 2078 LPG distributorships have been included in the current Marketing Plan all over the country. Locations included in the Marketing Plans are advertised by the oil marketing companies and selection is made by the Dealer Selection Boards. It generally takes about 6-12 months for commissioning of the dealerships/ distributorships from the date of interview.
