Apart from this, there is another scheme Assistance to States for Control of Animal Diseases with the following components:- (i) Systematic Control of Livestock Diseases of National Importance (ii) Animal Disease Surveillance and (iii) Foot & Mouth Disease Control (FMD) which is being implemented in all States/UTs. on 50:50 funding pattern.
