from the Government of Rajasthan for allocation of Naptha for production of Soda Ash, Urea, Di-ammonium Phosphate and to set up a Petrochemical Complex in the State. Marketing and Pricing of Naphtha stand decontrolled with effect from 1-4-1998. Consequently, Government does not make allocation of Naphtha to consumers in various sectors, except the power sector for which Naphtha allocation is made in accordance with the new Liquid Fuel Policy.

## Decline in milk production in Haryana and Rajasthan

2930. SHRI SURYABHAN PATIL VAHADANE : Will the Minister of AGRICULTURE be pleased to state :

- (a) whether it is a fact that the production of milk has declined in Haryana and Rajasthan due to which there is always shortage of milk in DMS depots and mother dairy depots;
- (b) if so, whether Government have made any review on the milk output in these States:
  - (c) if so, the details thereof; and
- (d) the proposals of Government to increase the output of milk in Haryana and Rajasthan ?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI HUKUMDEO NARAYAN YADAV): (a) to (c) No Sir, on the contrary the production of milk in Haryana and Rajasthan has increased in the last few years. Milk production in the last 3 years in Haryana and Rajasthan is as follows:—

## Illegal Collection of Prawn at Orissa Coast

2931. SHRIMATI JAYAPRADA NAHATA : SHRI AMAR SINGH :

Will the Minister of AGRICULTURE be pleased to state:

- (a) whether Government arc aware that illegal collection of prawn seedings has become a flourishing trade alongwith the Orissa Coasts; and
  - (b) if so, the details thereof and Government's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI HUKUMDEO NARAYAN YADAV): (a) and (b) Reports of wild prawn seed collection in coastal areas have been received by the Government of Orissa. The State Government has banned illegal collection and transport of wild shrimp seed through a notification dated 14-2-1994 issued under the Orissa Marine Fishing Regulation Act, 1982. The District Collectors of coastal areas and the concerned railway authorities have been directed to take action against violators. Apart from the action taken by the State Government, the Aquaculture Authority has also issued clear guidelines prohibiting the use of wild prawn seeds in the country.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI SBPBK SATYANARAYANA RAO) : (a) to (c) It is primarily the
