- (c) whether Government have any new proposal for further disinvestment; and
  - (d) if so, how much it will be done?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING AND THE MINISTER OF STATE OF THE DEPARTMENT OF DISINVESTMENT (SHRI ARUN JAITELY): (a) to (d) ERBC (Eastern Region Business Centre) covers activities of ONGC in North-Eastern areas except Tripura and is not an independent company or entity. Thus, no disinvestment of ERBC as such has been done. Presently, there is no proposal for further disinvestment in ONGC.

## Revaluation of Assets of PSUs before Disinvestment

THE MINISTER OF STATE IN THE MINISTRY OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (DR. VALLABH BHAI KATHIRIA): (a) to (C) In the Ministry of Heavy Industries and Public Enterprises, out of available 35 LDCs, (Typists) and 23 stenographers, only 8 eligible typists and 8 eligible stenographers are yet to be trained in Hindi typing/stenography. Training is a continuous process and staff is deputed for training keeping in view the exigencies of work.

## Heavy Industries Running in Loss

Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

- (a) whether it is a fact that there are large number of heavy industries run by Government which are constantly running in loss and now they have been declared sick industries;

VALLABH BHAI KATHIRIA): (a) to (c) As on 31.3.99, there were 50 CPSUs under Department of Heavy Industries (DHI) including two holding companies of which 25 CPSUs were sick and registered with BIFR. The total capital investment, in terms of equity participation and long term loan, made by the Central Government in these sick CPSUs as on 31.3.99, the period for which information is available, was Rs. 2653.59 crores.
