Pollution by Soil excavation by Brick Kilns

- 182. SHRI PRANAB MUKHERJEE: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:
- (a) whether it is a fact that excavation of soil and manufacture of kiln bricks out of such soil causes environmental pollution, loss of flora and fauna and is harmful to bio-diversity;
- (b) whether it is also a fact that soil being excavated for manufacture of kiln bricks is a valuable commodity and, if unchecked, can, in future, become a scarce commodity; and
- (c) what measures have been initiated and proposed, to remedy the ill-effects?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI BABU LAL MARANDI): (a) and (b) Yes, Sir.

(c) In order to conserve top soil, the Government has made it mandatory vide its Notification dated 14.9.1999 for brick manufacturers, located within 50 kms from any coal or lignite based Thermal Power Plant, to use at least 25 per cent of fly-ash, bottom ash or pond ash, with soil, on weight to weight basis, for manufacture of clay bricks, tiles or blocks used for construction activities. Every coal or lignite based Thermal Power Plant is required to make available as free of cost for at least ten years, for manufacturing ash based products such as cement, concrete blocks, bricks or any other material or for construction of roads, embankments, dams, dykes or for any other construction activity.

Neglect of Lions in Gir Forest

- 183. SHRI YADLAPATI VANKAT RAO: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:
- (a) whether it is a fact that Gir forest officials are neglecting lions in the park;
- (b) if not, the reasons for increase in lion deaths in the past four years; and

(c) the measures proposed to increase lion population?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI BABU LAL MARANDI): (a) No., Sir.

- (b) There is no increase in Lion deaths in the past four years.
- (c) Measures taken by the Government to increase lion population are given in the Statement.

Statement

- (i) Steps have been taken to improve the bioproductivity potential of the area by implementing soil and moisture conservation works, improvement of grass reserves, eradication of unwanted growth etc.
- (ii) Check posts have been established at sensitive points all along the periphery to prevent illegal activities.
- (iii) Field staff has been provided with arms and ammunitions and vehicles for patrolling.
- (iv) Wireless stations have been set up for better communication and response.
- (v) Eco-development works have been taken up in the revenue villages, forests settlement villages and maldhari nesses for improving the village economy in order to reduce biotic pressure on the protected area.
- (vi) Nature education and awareness camps are held to create awareness among the masses.
- (vii) Cattle immunisation camps are organised to prevent disease transfer to wild herbivores.
- (viii) Fire lines are prepared to minimise damage to the habitat by fire.
- (ix) Habitat of lion meta populations around Gir is also being improved as a result of which poulation of lion has increased from 284 in 1990 to 304 in 1995.
