## Appointment of Dealers for Chemical Fertilizers

\*†151. SHRI ONKAR SINGH LAKHAWAT: Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether Government are considering to issue effective guidelines for appointment of dealers for ensuring availability of chemical fertilizers to farmers in the country at reasonable price and at proper time;
  - (b) if so, what steps are being taken in this direction; and
- (c) the number and details of complaints received against the fertilizer dealers in Rajasthan alongwith the number of dealers whose licences have been cancelled?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI RAMESH BAIS): (a) and (b) Dealers are appointed by the suppliers looking to their commercial requirement and marketing needs while licence for distributionship is given by the respective State Government. This is true of all fertilizers. However, urea is the only fertilizer which is controlled and for which allocations are made State-wise. Urea suppliers are arranged to the State as per the allocation on aggregate basis by the Government of India. The distribution within the State is

the responsibility of the respective State Government which is also responsible for enforcing the notified maximum retail price (MRP). The supply and availability of all decontrolled fertilizers are arranged directly by the State Governments through the suppliers.

Urea is sold at MRP of Rs.4000/- MT throughout the country. The MRP of decontrolled fertilizers except ammonium sulphate, ammonium chloride and calcium ammonium nitrate are also fixed by the Government and are uniform throughout the country.

(c) The State Government of Rajasthan has reported that three complaints were received during 1999-2000, of which one was relating to adulteration from District Sawaimadhopur and the other two complaints are regarding black-marketing from Districts Bharatpur and Banswara. Overall seven dealers' licences were cancelled for irregularities under Fertilizer (Control) order during 1999-2000.
