(b) and (c) (1) Kendriya Vidyalayas:

Kendriya Vidyalaya Sangathan have received proposals for opening new KVs at Sibsagar and Dibrugarh, but due to fund constraints there does not seem to be a possibility of their opening.

(2) Navodaya Vidyalayas:

It is endeavoured to open one Jawahar Navodaya Vidyalaya in each District of the State subject to provision by the State Govt. of 30 acres of suitable land free suitable temporary accommodation for initial establishment of JNV, till Samiti constructs its own Vidyalaya Complex on the permanent site, and availability of financial resources. Out of 23 existing Districts in the State of Assam, 20 Districts have already been covered under Navodaya Vidyalaya scheme. In respect of remaining Districts, namely Dhubri, Nagaon and North Cachar Hills, opening of JNVs will depend upon receipt of suitable proposals from the State Govt., fulfilling above norms of the Samiti.
