(b) if so, whether Central Government have taken any immediate steps to save the wild animals and with what results?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI BABU LAL MARANDI): (a) and (b) The Gujarat Government has taken several measures to ensure availability of drinking water on a regular basis to the wild animals in Gir forests. Govt. of India has also released central assistance of Rs. 40.00 lakhs under the centrally sponsored scheme, Development of National Parks and Sanctuaries during the current financial year to augment the resources of the state Government to tackle the drought situation. As reported by the state Government no wild animal has died due to the water scarcity caused by the drought.

#### **Rail Track Between Ahmedabad and Mumbai**

\*494. SHRI BRAHMAKUMAR BHATT: Will the Minister of RAILWAYS be pleased to state:

(a) whether the former Minister of XII Lok Sabha had visited Gujarat and had assured that a third rail track between Ahmedabad and Mumbai on the basis of the heavy traffic there would be laid;

(b) if so, whether the survey was conducted; and

(c) if not, by when the survey would take place and on which date survey report would be sent?

THE MINISTER OF RAILWAYS (KUMARI MAMATA BANERJEE): (a) No, Sir. However, an announcement was made that Final Location Survey would be started.

(b) and (c) Based on Preliminary Engineering-cum-Traffic Survey done, it has been decided to take up the work in a phased manner and in first phase, 3rd line between Surat and Kosamba has been included in the Budget 2000-01. Final Location Survey for this stretch is now being taken up.

#### **Poor Status of Primary Education in Orissa**

\*495. SHRI GANDHI AZAD: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether it is a fact that the status or infrastructure of primary education is very poor in Orissa;

(b) whether it is also a fact that drop-out rate is above 70 percent and it is more than 90 percent among tribal girl children; and

(c) if so, what are the details thereof?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (DR. MURLI MANOHAR JOSHI): (a) to (c) The State of Orissa is below the national average in several indicators related to primary education, such as literacy rate, drop-out rate, availability of pucca school buildings, drinking water/toilet facilities, etc. The overall drop-out rate at the primary level is 46.01% (1998-99) and it was 74.14% (1990-91) amongst tribal girls and not 70% and 90% respectively as stated in the Question. The status/infrastructure of primary education in Orissa in terms of major indicators, as compared to national averages, is as follows:—
