THE MINISTER OF STATE IN THE MINISTRY OF SURFACE TRANSPORT. (DR. DEBENDRA PRADHAN): (a) and (b) In all 112 promotions were made in IRCC between 1991-93, as per approved sanctioned strength and vacancy position and the same were approved by the Board of Directors which is the competent authority. General as well as reserved category of employees were given benefit of promotion as per rules.

As per R and P Rules mere completion of eligibility does not confer any right for promotion.

- (c) While holding DPC for promotion, IRCC followed the requirements as stipulated in its R and P Rules, Presidential Directives and Govt. rules uniformly.
- (d) This was done under the provisions of R and P Rules of the Corporation, Presidential Directives and Govt. rules etc.
