Corporatisation of Ports

577. MISS MABEL REBELLO: SHRI SURESH KALMADI:

Will the Minister of SURFACE TRANSPORT be pleased to refer to answer to Starred Question 239 given in the Rajya Sabha on 14th December, 1999 and state:

- (a) whether the corporatisation of ports will grant them more autonomy; and
 - (b) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF SURFACE TRANSPORT (DR. DEBENDRA PRADHAN): (a) Yes, Sir.

(b) Corporatisation of Ports involves converting them into companies which will have the independence of authority and decision making. It aims at granting operational freedom and flexibility to management in taking commercial and investment decisions. The Government control in these companies is proposed to be kept at necessary minimum level.

Recommendations of National Commission for SC/ST in IRCC

- (c) by when Government propose to fully implement the Commission's directives, otherwise the reasons therefor;

- (d) the details of employees promoted without vacancies during 1991-93 in the Corporation; and
 - (e) the post-wise reserved vacancies still existing in NHAI?

THE MINISTER OF STATE IN THE MINISTRY OF SURFACE TRANSPORT (DR. DEBENDRA PRADHAN): (a) to (c) The National Commission for SC/ST vide their letter dated 29.1.98 made certain observations regarding promotion of few SC/ST employees based on the representation of SC/ST employees, which were suitably replied vide IRCC's letter No. 701100 dated 26.2.1998 explaining the factual position.

It is further stated that no communication dated 22.1.1999, from National Commission for SC/ST, has ever been received by IRCC Limited. However, the officers of Commission inspected the office records and 40 point roster on 16.9.96 and expressed their satisfaction.

- (d) All the promotions held in IRC¢ between 1991-93 were made as per approved sanctioned strength and vacancy position reviewed and ratified by the Board, which is the competent authority.
- (e) Information is being collected and will be laid on the Table of the House.
