

COMMUNICATIONS (SHRI TAPAN SIKDAR): (a) 30 villages have been identified in far-flung areas of Himachal Pradesh to provide telecom facility on satellite phones. Names of these villages are:—

**ISD/STD/PCO facilities in Rural and Adivasi areas of Maharashtra**

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI TAPAN SIKDAR): (a) to (c) No Sir. Out of 42060 villages in Maharashtra State, 31005 villages have been provided with VPTs. 45 VPTs have been provided with STD/ISD facilities. Out of 2882 exchanges operating in Rural areas including Adivasi areas, 1456 exchanges are having STD/ISD facilities. Government plans to provide STD/ISD in the remaining exchanges by the year 2001.

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI TAPAN SIKDAR): (a) A Draft Audit Para titled "package of concessions to existing Cellular and Basic Telephone Service Operators" was received from Director General of Audit, Post and Telecommunications. Salient aspects of Audit observations on the Package offered to existing Basic and Cellular Mobile Telephone Service Licensees for migration to New Telecom Policy-1999 (NTP-1999) regime are enclosed as Statement-I (See below).
