- (v) the DRDAs of Nowrangpur in Assam for mis-utilization of funds under EAS.
- (c) The comments of the concerned State Governments are being collect. Appropriate action will be taken on receipt of the comments.

New Textile Policy

- 283. SHRI BHAGABAN MAJHI: Will the Minister of TEXTILES be pleased to state:
- (a) whether Government propose to introduce a new Textile Policy.
 - (b) if so, the salient features thereof;
 - (c) the expected time for its introduction; and
 - (d) the steps taken in that direction?

THE MINISTER OF STATE IN THE MINISTRY OF TEXTILES (SHRI GINGEE N. RAMACHANDRAN): (a) Yes, Sir,

(b) to (d) An Expert Committee was appointed under the Chairmanship of Shri S.R. Sathyam in July, 1998 to inter-alia, review and evaluate the impact of the existing textile policy, and identify the changes that are now necessary, particularly in the context of the new imperatives of international competition. The Committee has since submitted its report. The recommendations of the committee are under consideration in the Ministry for finalisation of the new Textile Policy.

(c) In order to supplement the efforts of the State Sericulture Departments, the Central Silk Board (CSB) is implementing a number of schemes/projects/programmes for promoting development of silk. These include schemes for extension of R&D, training, infrastructural & extension support to the sector through network of CSB's units & implementation of certain developmental/incentive/financial assistance schemes for encouraging adoption of modern sericultural practices for production of quality silk.

The Sub-Group on sericulture for IX Plan had recommended an incremental production of 6540 M.T. of raw silk during IX Plan period (1997—2002). It is estimated by the Sub-Group that by end of IX Plan (2002), the raw silk production in the country will reach 20666 M.T. from the level of 14126 M.T. in 1996-97 (VIII Plan end).
