

traffic on 1.10.94. The work on the left over portion from Shimoga town to Talguppa (98 kms) was sanctioned in 1997 as second material modification to Bangalore-Hubli and is in good progress. The overall progress achieved on this section is 15% and there is no delay.

(iv) Solapur (Hotgi)-Gadag (300 kms.)

The project was sanctioned in 1993-94. The work has been taken up in phases and sections between Solapur-Hotgi and Hotgi-Bijapur have been completed and commissioned. The work is in progress on rest of the section which will be completed in the coming years depending upon availability of resources.

(d) No target dates have been fixed. These projects are being progressed as per priority fixed by the Government and will be completed in the coming years subject to availability of resources.
