Infrastructure Equalisation for North-East

Towards this end, a Non-lapsable Central Pool of Resources has also been constituted for assisting development projects, including in the infrastructure sector, in the North East and Sikkim.

Certain projects (including some recommended by the Shukla Commission) have since been identified for assistance from the Non-lapsable Central Pool of Resources and funds released during the financial year, 1998-99. Similar exercise is being pursued during the current financial year also. The developmental objectives of the North Eastern States (and Sikkim) are also being appropriately pursued through the Five Year Plans and Annual Plans of these States and of the Central Ministries and Organizations.

Non-Lapsable Central Pool for North-East

OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (SHRI ARUN SHOURIE): (a) to (c) A Non-lapsable Central Pool of Resources has been constituted out of unspent amounts from 10% of the Budgets of the various Central Ministries/Departments, which is to be utilized to assist development projects, including those in the infrastructure sector, in the North East and Sikkim. A Committee has been constituted to administer the Non-lapsable Central Pool of Resources. Project proposals received in the Planning Commission are considered by this Committee and recommended for assistance from the Central Pool keeping in view the merits of the projects and availability of funds in the Pool.

During 1998-99, an amount of Rs. 121.95 crores was identified for the Central Pool and assistance to this extent was released for various projects in the North East and Sikkim. A list of such projects is given in statement. (See below)

All schemes received from the various State Governments have been considered and some additional projects to be funded out of the Non-lapsable Central Pool of Resources are under active consideration.
