THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI JAYSINGRAO GAIKWAD PATIL): (a) and (b) Yes, Sir. Their demands, inter-alia include revision of pay scales of PRTs, grant of TGT grade to Music Teachers, reduction on department period from five years to one year on refusal to accept promotion, conversion of CPF to GPF, Departmental promotion within Region for PRTs, TGTs & PGTs, payment of Special Duty Allowance to all employees serving the North Eastern Region irrespective of their residential status.

(c) and (d) Yes, Sir. The General Secretary of the Association has been charge-sheeted for his mis-conduct as defined under CCS (Conduct) Rules, 1964 as applicable/extended to KVS employees.

Violation of Transfer Priority by KVS
