It includes coordinated and planned development of technical education as embodied in the All India Council for Technical Education Act, 1987. The measures taken for modernisation and removal of obsolescence; development of thrust areas in technical education; research and development; as also several other initiatives taken by the All India Council for Technical Education help the States to develop technical education.

(c) and (d) There is no proposal, at present, to establish any new Indian Institute of Technology (IIT).
