**THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI JAYSINGRAO GAIKWAD PATIL):** (a) and (b) Revamping of technical education in the country is a continuous process and is achieved through the implementation of the National Policy on Education (NPE) and the Programme of Action (PoA) thereunder. It includes coordinated and planned development of technical education as embodied in the All India Council for Technical Education Act, 1987. The measures taken for modernisation and removal of obsolescence; development of thrust areas in technical education; research and development; as also several other initiatives taken by the All India Council for Technical Education help the States to develop technical education.

(c) and (d) There is no proposal, at present, to establish any new Indian Institute of Technology (IIT).

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI JAYSINGRAO GAIKWAD PATIL): (a) As per information furnished by the Central Board of Secondary Education (CBSE), affiliation has been granted to 802 schools by the Board since 1.4.1997 till date as per list given in the enclosed Statement. (See below.)

(b) to (d) The school can be started by any Registered Society/Trust as per the Rules & Regulations of the concerned State/UT. The CBSE grants affiliation to the schools who fulfil various conditions prescribed in the Affiliation Bye-laws of the Board which inter alia prescribe minimum requirements in terms of land, building, management, teaching staff, salaries, syllabus etc. and a no objection certificate from the concerned State Government/UT Administration. However, the condition regarding submission of no objection certificate is not applicable in the case of certain categories of schools like the schools run by the Government or managed by Public Sector Undertakings etc. No school was given affiliation during the last 3 years without obtaining required No Objection Certificate.
