- (a) whether it is a fact that Shimla Television Station in Himachal Pradesh has been fully equipped with the modern technology;
- (b) if so, whether it is also a fact that the telecast from this station is restricted to a very small part of Himachal Pradesh; and
- (c) if so, what action/steps Government propose to take or have taken to ensure that telecast is viewed by the people of whole of Himachal Pradesh?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI ARUN JAITLEY): (a) Yes, Sir. (b) Programmes telecast from 1 KW High Power Transmitter at Shimla have a reach of 35 Kms.

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI ARUN JAITLEY): (a) to (c) There is no separate policy for different regions/states for telecast of cultural programmes. However, it is the continuous endeavour of Doordarshan to telecast programmes on its Kendras as well as National Network to project unique art, music, cultural heritage and literature of the regions/states including Himachal Pradesh. Details of programmes depicting art, culture and heritage of Himachal Pradesh telecast on Doordarshan during the last 3 years are given in the statement (See below).
