(d) if so, the number of precious lives of officers lost therein?

(d) Number of lives lost in this incident was four.

#### **BSF Intimation about Pak Movement In Kargil**

(a) whether as reported in the Indian Express of May 28, 1999 at page 1, the BSF had informed Government that Pakistan backed infiltrators and army regulars had occupied the higher reaches of Kargil as early as January, 1999, but these movements had gone unnoticed by troops till April and the Army brigade was taken unawares; and
