Sayyed Abdul Ala at Bangalore, business premises of the accused at Bhagirath Place and residences at New Friends Colony and Teliwara Azad Market, New Delhi were also searched which resulted in recovery of 32.5 Kgs. Heroin and 70 litres of Acetic Anhydride, a precursor chemical used for manufacturing of heroin.

(d) Instructions have been issued to all the Enforcement Agencies to maintain utmost vigil and to step up enforcement efforts under the stringent provisions contained in Narcotics Drugs and Psychot-rophic Substances Act. Drug Enforcement Officers are also being trained to improve their effectiveness. Quarterly Coordination meet-¹ ings are being held by the Narcotics Control Bureau, New Delhi for proper coordination of drug enforcement efforts by all the concerned Central and State agencies in the country. Reward scheme for informers and Enforcement Officers is also being implemented vigorously.

Special recruitment from Assam

856. DR. (MRS.)
