- 939. SHRI SURYABHAN PATIL VAHADANE: Will the Minister of LABOUR be pleased to state:
- (a) the number of unemployed in live register of employment exchange in Maharashtra state district-wise at the end of the year 1997, 1998 and 1999 (upto Nov. 1999);
  - (b) the number of such persons given employment district-wise; and
  - (c) the steps by Government to absorb most of the persons so registered?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI MUNI LALL): (a) As per the information supllied by the Government of Maharashtra the number of unemployed persons who were on the Live Register of the Employment Exchanges at the end of 1997, 1998, and at the end of October, 1999 according to district is given in Statement — I. (See below)

- (b) The number of person placed during the year 1997, 1998 and 1999 (upto October) district-wise, is given in Statement II. (See below)
  - (c) Government of Maharashtra has started following schemes.
- 1. Employment Promotion Programme. This scheme is implemented since 1975-76. The main objective of this scheme is to help educated local unemployed to upgrade their skills and ability by providing them inplant training with the Employer in Private Sector or Government undertakings so as to enable them to get regular employment or start their own self employment ventures after the completion of the training. Duration of training under this scheme is Six Months and the trainees are paid monthly stipend ranging from 30(y- to Rs. 1000- depending upon their educational qualifications.
  - 2. Coaching Cum Guidance Centre for Tribals: In spite of the

reservation for Scheduled Tribe candidates in State Government Service, all the vacancies could not be filled up for want of suitable Scheduled Tribe Candidates. To prepare Scheduled Tribe Candidates for competitive examinations, 3 Training Classes per annum, each class being of 3<sup>1</sup>/<sup>8</sup> months duration, are conducted by these centres. The trainees are paid stipend of Rs. 37y- per months. The candidates with matriculation and higher qualifications are eligible for these coaching classes. Lecturers from nearby colleges are appointed on hourly basis to teach the classes. They are paid honorarium @ Rs. 4(K- per hour. Besides this, trained and knowledgeable officers from banks, financial institutions, experts from reputed social institutions are also invited to guide the trainees as requirements. After completion of course, the participants are informed about various vacancies, competitive examinations and are supplied with applications forms. Special coaching cum guidance classes are also arranged as and when required.

3. Apart from this Government of Maharashtra has created separate Employment and Self-Employment department under which Self-Employment Scheme are being implemented.
