- (a) whether a policy has been formulated to redeem bidi workers from the exploitation by the factory owners;
  - (b) if so, the details thereof;
- (c) whether some price rate has been fixed for bidi workers for bidi making; and
  - (d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI MUNI LALL): (a) and (b) Beedi &

Cigar Workers (Conditions of Employment) Act, 1966 has been enacted to safeguard the interests of workers engaged in beedi-making. This Act is being implemented by the State Governments. They have formulated Rules under this Act to ensure proper implementation of various provisions of the Act.

Apart from this, the Government is implementing various schemes in the fields of Health, Housing, Education, Recreation and Social Security under the Beedi Workers Welfare Fund Act, 1976 for the welfare of beedi workers and their dependants.

(c) and (d) State Governments, who are the appropriate Governments for the fixation and revision of minimum wages for the workers employed in Beedi Industry under the Minimum Wages Act, 1948 have fixed rates for making beedi, in their respective States. A list of such rates is attached at statement.
