## Increase in Price of Wheat, Rice and Sugar in PDS

986. DR. MOHAN BABU: Will the Minister of CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION be pleased to state:-

- (a) whether Government have recently increased the prices of wheat, rice and sugar under the Public Distribution System;
  - (b) if so, the justification thereof;
- (c) the amount of subsidy provided by Government during the last three years and the amount of subsidy withdrawn recently by Government;
- (d) whether Government are aware that increase in prices would adversely affect the people belonging to the weaker sections of society; and
  - (e) if so, whether Government would consider to reconsider the decision?

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI SHRIRAM CHAUHAN): (a) No. Sir.

(b) Central Issue Prices (CIPs) of Rice and Wheat for Above Poverty Line (APL) population only, were revised on 29.01.1999, and again for wheat on 1.04.1999 with a view to neutralising the financial burden consequent upon the increase in MSPs of wheat and paddy and also to contain the food subsidy bill to a manageble level.

The retail issue price of sugar was revised from Rs. 11.40 per kg. to Rs. 12.00 per kg. on 15.02.1999.

(c) Subsidy provided by the Government during the last three years has been as under:

Due to increase in the CIPs of wheat and rice on 29.01.1999, and wheat on 01.04.1999, the likely reduction in subsidy bill on foodgrains will be around Rs. 2330 crores during 1999-2000.
