IAY Funds to Andhra Pradesh

1484. SHRI SOLIPETA RAMACHANDRA REDDY: Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the amount allotted and the expenditure incurred in Andhra Pradesh under Indira Awaas Yojana during the last three years;
- (b) whether Government are aware that the amount allotted for a house is quite insufficient in view of the hike in the prices of building material; and

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI SUBHASH MAHARIA): (a) The amount allotted under Indira Awas Yojana during the last 3 years for Andhra Praesh is Rs. 327.64 crores (Centre+State). As per information made available by the government of Andhra Pradesh.

an amount of around Rs. 353.65 crores have been utilised under this scheme during the last three years.

(b) and (c) As per existing Indira Awas Yojana Guidelines, the ceiling of construction assistance under Indira Awass Yojana is Rs. 20,000/- for plain areas and Rs. 22000/- for hilly/difficult ar;as which is considered adequate for the time being. At present th;re is no proposal under consideration of the Government for raising the ceiling of construction assistance under Indira Awass Yojana.
