## Losses to SEBs

- 1477. SHRI SUKHDEV SINGH LIBRA: Will the Minister of POWER be pleased to state:
- (a) the names of State Electricity Boards incurring huge losses continuously for the last three years, year-wise;
- (b) the assistance provided by the Central Government to improve their condition;
  - (c) the amount due from each S.E.B. to the Centre, as on date; and
  - (d) the steps taken by Government to realise the dues?

THE MINISTER OF STATE IN THE MINISTRY OF POWER (SHRIMATI JAYAWANTI MEHTA): (a) A statement indicating the mames of the State Electricity Boards (SEBs) who have been continuously making losses during 1995-96, 1996-97 and 1997.98 is enclosed as statement I (see below). The accounts for the year 1998-99 from most of the SEBs have not been received.

- (b) To improve the condition of SEBs the process of reforms and restructuring of SEBs has been initiated. This includes unbundling and corporatisation of SEBs. Setting of SERCs by the State Governments are also expected to lead to improvement of efficiency of SEBs.
- (c) As reported by various Public Sector Undertakings of Power Sector the amount due from each SEB/Power Utilities as on 31.10.1999 is enclosed as Statement II. (See below).
- (d) Government has resorted to recoveries from the ' Central Plan Assistance (CPA) payable to the State Governments.
