THE MINISTER OF STATE IN THE MINISTRY OF CON-SUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI V. SREE NIVASA PRASAD): (a) The Super Bazar, Delhi has sustained losses during the last three years. The year wise position of losses sustained are as under:

## Revamping of PDS

- (a) whether Government's attention has been drawn to the newsitem published in Dainik Observer of 24th November, 1999 under the caption, "Total revamp of PDS on cards";
- (b) if so, whether Government have taken a decision to bring comprehensive improvements in the present Public Distribution System:
  - (c) if so, the reasons therefor; and
- (d) whether any proposal is being considered with regard to the new or improved system; if so, the broad outlines the cof?

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI SRIRAM CHAUHAN): (a) Yes, Sir.

- (b) to (d) The Government has been receiving inputs that the current Targeted Public Distribution System (TPDS) suffers from several inadequacies a few of which are as under:
  - (i) The quantity of foodgrains supplied is insufficient;
  - (ii) The quality of foodgrains is also sometimes poor;
  - (iii) Although the objective of TPDS was to focus on poor, the quantities of foodgrains supplies to the population below poverty line is the same as the population above poverty line;
  - (iv) A better package in favour of poor should be evolved by the Government under T.P.D.S. to make it socially more relevant and economically more attractive;
  - (v) The subsidy burden under the T.P.D.S. should be reduced by evolving a more positive price policy in favour of poor with more supplies while ensuring adequate supplies to non-poor and ensuring at the same time that the diversion of commodities under the T.P.D.S. is minimized:
  - (vi) Timely supplies need to be ensured by better organisation of the delivery system;
  - (vii) Delivery system and issue of ration cards should be transparent and subjected to social audit; and
  - (viii) Menace of the bogus ration cards should be eleiminated.

Suggested improvement involve the decisions by the Union Government and the State/UT Governments. Review and consequent improvement in the T.P.D.S. is a continuous process and involves the representatives of civil society, academics and experts. Government has decided to evolve a consensus on the issue by associating all concerned in the forseeable future, including the State Government.
