Stigma With HIV

1759. SHRI RAMDAS AGARWAL: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether Government's attention has been drawn to a newsitem published in the Hindustan Times dated the 1st December, 1999 captioned HIV is highly stigmatised in India as stated in a Report issued by the joint United Nations Programme on HIV/AIDS (UNAIDS) and the World Health Organisation (WHO);
 - (b) if so, what are the details thereof;
- (c) whether it is a fact that total HIV infections in India are estimated around 40 lakh, which is more than any other country; and
- (d) if so, what preventive measures Government have taken so far in this regard?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI N.T. SHANMUGAM): (a) and (b) Yes, Sir. However, the HIV infected persons are not stigmatised but are treated at par with other patients in general words of all Government Hospitals.

- (c) The total HIV infection in India is estimated to be around 35 lakhs. This is based on the total population of India.
- (d) In order to prevent and control the spread of HIV/AIDS in India, a comprehensive Programme is currently under implementation throughout the country as a centrally sponsored scheme. The main strategy consists of:—
 - * Strengthening programme management capabilities at central and state level.
 - * Creation of awareness amongst high risk behaviour groups and general public about HIV/AIDS.
 - * Control of Sexually transmitted diseases and condom promotion.

- * Promoting blood safety and rational use of blood through proper licensing of blood banks and encouraging voluntary blood donations.
- * Strengthening capacity for surveillance and diagnosis; and
- * Extending training in clinical Management of HIV/AIDS cases.

Control of Population

1760. SHRI S. AGNIRAJ: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) the total population of the country* as on 1999;
- (b) the steps being taken to control the population drastically;
- (c) whether it is a fact that proper publicity and funds are lacking with the State Government to ensure family planning; and
 - (d) if so, reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI N.T. SHANMUGAM): (a) The total population of the country on 1st October, 1999 is projected to be 990.41 million.

- (b) The National Family Welfare Program has now been sub stantially re-organized and strengthened through the following steps;
 - (i) An integrated and holistic program of Reproductive and Child Health that include Maternal Health, Child Health and Contraception issues was launched in October, 1997;
 - (ii) Information, Education and Communication Program to create awareness about the benefits of small family;
 - (ii) Assistance to States/UTs to maintain certain family welfare infrastructure;
 - (iv) Assistance to Voluntary Organizations and NGOs for implementing family welfare program.
- (c) Sufficient funds are being provided to the State Governments for IEC/publicity activities, Publicity campaign has been further
