(a) whether Special Central Assistance is given by the Central Government to the States under Demand Nos. 41 and 64;

(b) if so, what are the arrangements made for its evaluation and implementation;

(c) whether the amount so allocated is being utilised for sub-plan areas or diverted to other areas;

(d) what are the details of allocations made in this regard during the years 1997-98 and 1998-99, State-wise; and

(e) what is the name of the agency in Madhya Pradesh through which the execution of Special Central Assistance is being done?

THE MINISTER OF TRIBAL AFFAIRS (SHRI JUAL ORAM): (a) No, Sir. This Ministry does not give Special Central Assistance to the States under Demand Nos. 41 and 64.

(b) to (e) Do not arise.

#### **Housing for Tribals by Local ITDAS in Andhra Pradesh**

(a) whether it is a fact that a number of representations have been made by social activists regarding housing for tribals in Andhra Pradesh by the local ITDAs;

(c) which are the districts in Andhra Pradesh where a demand has been made in 1998-99 and the current year; and

(d) the reasons for ignoring such demands?

THE MINISTER OF TRIBAL AFFAIRS (SHRI JUAL ORAM): (a) Yes, Sir.

(b) and (b) Government of Andhra Pradesh has been requested to consider the construction of houses for the tribals of West Godavari District and action is being taken by them, being the implementing authority. However, and officer also visited West Godavari District during November, 1998 in this regard.

### **Solar Home Lighting System for SCs and STs in Tripura**

1963. SHRI KHAGEN DAS: Will the Minister of TRIBAL AFFAIRS be pleased to state:

(a) whether any project proposal has been by the Government of Tripura for providing Solar Home Lighting System to Scheduled Tribes and Scheduled Castes people in Tripura during the Ninth Plan period;

(b) the fund sought for the purpose under Additional Special Central Assistance; and

(c) whether any fund was released during 1997-98 and 1999?

THE MINISTER OF TRIBAL AFFAIRS (SHRI JUAL ORAM):

(a) Yes, Sir.

(b) Government of Tripura has sought for financial assistance to the tune of Rs.375.00 lakhs during the Ninth Five Year Plan as Additional special Central Assistance for providing Solar Home Lighting System for Scheduled Tribes.

(c) The proposal of the State Government is under scrutiny, Hence, funds have not been released by the Ministry for the purpose,
