1996 and since then only nine applications have been received from Harmonium Players in Carnatic music for audition. Solo performance in All India Radio is allowed only to those artists with "A" Grade or above and since there is no "A" Grade artist in Harmonium, no Solo performance has been allowed. All India Radio have also clarified that there is no instrument called modern/electronic Harmonium. With a view to attract the talents, the payment to artists of electronic effect instruments like keyboard, synthesiser etc. has been recently revised.
