- (b) whether it is also a fact that the money meant for tribal welfare is diverted for other areas/sectors in the States;
- (c) what is the criterion of allocation of funds for the tribal development in the States; and
- (d) whether Government have devised any mechanism to utilise the funds exclusively for the tribal welfare in the same year?

THE MINISTER OF TRIBAL AFFAIRS (SHRI JUAL ORAM):
(a) Yes Sir, some of the States are directing the funds.

- (b) While reviewing it has been seen that many States are not spending for the purpose which money was sent. State Governments are not submitting Utilisation Certificate regularly.
- (c) The allocation of funds is usually made on the basis of the proposal received from the State Governments. Weightage is given for tribal population concentration in the State and backwardness of the area.
- (d) Guidelines have been issued by the Ministry of the States/UTs to utilize the funds during the same financial year. States have been advised to strengthen the monitoring mechanism for proper utilization of funds.
