THE MINISTER OF STATE IN THE MINISTRY OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (DR. VALLABH-BHAI KATHIRIA): (a) The number of PSUs set up in the North-East Region (NER) is given in the enclosed Statement (See below).

(b) and (c) The industrial units in the Central Sector are not planned State-wise. These projects are formulated by the Government and their location is decided based upon techno-economic considerations like availability of raw materials, infrastructure including power, roads, communication etc. and proximity to the market. Further, in the present liberalised economic environment, Industrial Sector stands largely delicensed and private sector is, therefore, free to decide making investment in industries anywhere in the country including in the North-East Region.

Closure of MAMC and BOGL

1892. SHRI JIBON ROY: Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be please to state:

- (a) whether it is a fact that he had made a statement in Rajkot on 18th October, 1999 stating that Government have decided to close down eight public sector industries, including MAMC, BOGL in Durgapur, West Bengal;
 - (b) if so, the reasons therefor;
- (c) whether it is also a fact that the previous Government had constituted an Expert Committee to consider the revival of those plants;
- (d) if so, whether the Committee has finalised their recommendations; and
 - (e) what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (DR. VALLABH-BHAI KATHIRIA): (a) and (b) Government had taken a decision to introduce Voluntary Separation Scheme (VSS) by extending benefits of Voluntary Retirement Scheme (VRS) to the employees of 10 unviable Public Sector Undertakings (PSUs) under the Department of Heavy Industry including MAMC & BOGL. BIFR/Disinvestment
