- (b) if so, whether it is a fact that a large number of consumers who have cleared their oustanding dues are waiting for re-connection in Malviya Nagar, South Delhi; and
- (c) how many such cases are pending in Malviya Nagar and the reasons for delay in providing reconnection and whether MTNL would give top-priority for reconnection and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI TAPAN SIKDAR): (a) Yes, Sir.

(b) and (c) As per report available, there is no such case pending for reconnection after release of OB. However 16 cases of restoration are pending at different stages, for reasons attributable to the subscribers themselves, like unpaid Demand Notes, changes in signatures and changes in customers' names.

E-mail facility is a part of Internet Service.

- (b) and (c) The access to Internet is available to the subscribers throughout the country on Local call basis excepting andaman & Nicobar Islands and Leh. The following are the Internet modes working in the North East Region:—
