- THE MINISTER OF STATE OF THE MINISTRY OF TOURISM (KUMARI UMA BHARTI): (a) to (d) The development of tourism is mainly undertaken by the State Governments. However, to supplement their efforts, Ministry of Tourism provides financial assistance to them for the projects/schemes prioritised every year in consultation with them.

During the last three years, 774 projects for development of tourism have been received in the Ministry of Tourism from all States in the country. These projects relate to construction/creation of tourist facilities namely; Wayside amenities, Tourist Bungalows, Tourist Reception Centre, Yatri Niwas, Refurbishment of monuments, Development of Pilgrim Centres, Sound and Light Show, Purchase of Adventure equipment etc. Sanctioned projects/scheme are implemented by the respective State Governments.
