THE MINISTER OF STATE IN THE MINISTRY OF SUR-FACE TRANSPORT (DR. DEBENDRA PRADHAN): (a) to (c) Major Ports are not availing Budgetary support from the Government for maintenance and running of the Ports. However, the Calcutta Port Trust is reimbursed expenditure incurred by them on dredging for the maintenance of the Port.

## Implementation of Recommendation of National Commission for SC/ST

- 2114. SHRI GOVINDRAM MIRI: Will the Minister of SUR-FACE TRANSPORT be pleased to state:
- (a) whether directives given from time to time by the National Commission for SCs and STs and the recommendation made by the Mittal Committee for IRCC (Indian Road Construction Corporation) have been fully and faithfully complied with in respect of promotion cases of SCs and STs employees during the preceeding five years; and
  - (b) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF SUR-FACE TRANSPORT (DR. DEBENDRA PRADHAN): (a) and (b) All the communications received from National Commission for SC/ST from time to time have been duly replied by IRCC. The main recommendations of the Mittal Committee Report have been implemented as approved by the Board of Directors of IRCC on 18.12.97. Further the Board in its 139th meeting held on 18.12.97, in view of the Govt.'s proposal to close down the Corporation, had decided not to make any promotions till further orders. There have been no promotion in IRCC in the last five years except the promotion of three eligible SC/ST employees, through review DPC, in the categories where promotions were made in IRCC between 1991—93.

(c) Government proposes to amend the Act.
