- (b) whether Government would contemplate to conduct an inquiry by a Joint Parliamentary Committee to look into this planned strategy of changing the structure of Tehri town; and
 - (c) if so, by when, if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF POWER (SHRIMATI JAYAWANTI MEHTA): (a) No special importance or favour has been given by THDC to the people of any particular community of Old Tehri Town in allotment of land for their religious places. Construction of all the religious buildings in lieu of structures existing in the Old Tehri Town have been done in accordance with the provisions of the prevailing Rehabilitation Policy which provides that the religious places would be constructed by the project to the extent possible. Keeping in view the requirements of the affected population, excepting where compensation for the existing structures of places of worship in Old Tehri Town has been taken from the THDC. Religious places of all the communities are being constructed in New Tehri Town in the same number as are existing in Old Tehri.

In the New Tehri Town, so far an amount of Rs. 2.34 crores has been spent on the construction of religious places, including Temples and two Mosques, in lieu of those existing in the Old Tehri Town.

(b) and (c): There is no such proposal under consideration.

Pending Proposals for Power Projects

THE MINISTER OF STATE IN THE MINISTRY OF POWER (SHRIMATI JAYAWANTI MEHTA): (a) During the period April - November, 1999, three states namely Jammu and Kashmir, Uttar Pradesh and Goa faced energy shortage of more than 10%

(b) to (d) Only two schemes pertaining to the State of Uttar Pradesh are pending for techno-economic clearance in Central Electricity Authority as on 30.11.1999. The details of these schemes, namely, Name of the project, Installed capacity and status are given below:
