2253. SHRI O.P. KOHLI: Will the Minister of RURAL DEVELOPMENT be pleased to refer to answer to Unstarred Question 155, given in the Rajya Sabha on 21st November, 1996 and state:

(a) whether it is a fact that land allotted under section 74(4) of Delhi Land Reforms Act has been sold and names changed in revenue records;

(b) if so, whether these errors were genuine or facts were suppressed knowingly, resulting into sale of land; and

(c) the action Government propose to take in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI A. RAJA): (a) to (c) Information is being collected from the Government of National Capital Territory of Delhi and shall be placed on the Table of the House.
