THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI E. PONNUSWAMY): (a) to (c) In addition to the locations pending from previous Marketing Plans, 69 LPG distributorships have been included in the current Marketing Plan for Punjab. This includes 7 LPG distributorships in Amritsar District and 5 LPG distributorship in district Ferozepur.

(b) and (c) Two Dealer Selection Boards were constituted for Punjab for making selections for locations pending in the State. In respect of 68 LPG distributorships which have already been advertised interviews are to be conducted by the Dealer Selection Boards in Punjab.
