Withdrawal of American Protest against Loans

THE MINISTER OF EXTERNAL AFFAIRS (SHRI JASWANT SINGH): (a) After the nuclear tests in May 1998, the US imposed certain economic restrictions on India under its domestic law. These restrictions included opposition to any loan to India by any

international financial institution Loans for humanitarian purposes by international financial institutions were exempted from the restrictions. On June 25, 1998, the World Bank had approved a loan of US \$ 543 million for projects in India designed to meet basic human needs. Loans from international financial institutions for meeting basic human needs continue to be available to India.

Vietnamese President's Visit to India

- (c) the details of the broad fields in which both countries have agreed to work for closer cooperation?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI JAS-WANT SINGH): (a) Yes, Sir.

(b) and (c) The President of Vietnam held talks without President, Vice-President and Prime Minister. Minister of Human Resource Development & Science & Technology, Finance Minister and External Affairs Minister, Leader of the Opposition and other political leaders called on him. The two sides exchanged views on bilateral, regional and global issues of mutual interest and while expressing satisfaction at the expanding cooperation in various fields, agreed to strive to enhance it further. The Vietnamese reaffirmed their support to India's candidature as a permanent member in an expanded Security Council. South-South cooperation was reiterated as a major plank of our foreign policy, a Credit Agreement, a Process Verbal for Exchange of Instruments of Ratification of the Bilateral Investment Promotion and Protection Agreement signed in 1997, an MOU on Setting Up of Software Human Resource Development
