# TV Tower at Raigarh in Jaisalmer

- †49. SHRI RAMA SHANKER KAUSHIK: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:
- (a) the date on which the highest TV. tower of Asia was installed at Raigarh of district Jaisalmer in Rajasthan togetherwith the expenditure incurred on it and purpose of its installation;
- (b) whether the said tower is functioning as per its capacity; if so, the details thereof; and
- (c) if not, the reasons therefor and persons responsible for this and the steps being taken by Government to completely ban the anti-India programmes being transmitted in the said area?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI ARUN JAITLEY): (a) High power (10 KW) transmitter with 300 M tower was commissioned at Ramgarh (not Raigarh) in Jaisalmer district on 31st March, 1997 at a capital cost of Rs. 8.76 crores, for the purpose of providing coverage in the border district of Jaisalmer.

- (b) The transmitter at Jaisalmer is operating on full power and relays transmission for about 15 hours a day.
  - (c) Does not arise.
