Losses in PSUs.

- 40. SHRI RAMDAS AGARWAL: Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:
- (a) how many PSUs were running into losses during the last three years till October, 1999;
- (b) what are the details thereof indicating the amount of losses of each PSU working under his Ministry; and
- (c) what steps Government have taken, so far, to minimise the losses of such PSUs?

THE MINISTER OF STATE IN THE MINISTRY OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (DR. VALLABHBHAI RAMJI BHAI KATHIRIA): (a) and (b) During 1995-96, 1996-97 and 1997-98, the period for which the information is available, 102, 104 and 100 PSUs respectively have incurred losses. The details of information in regard to name of the CPSUs and losses therein, including those which are under the administrative control of the Department of Heavy Industries in the Ministry of Heavy Industries and Public Enterprises, are available at Statement 7B, of the Public Enterprises Survey volume-I 1997-98, which was laid in the Parliament on 26.2.99.

(c) Enterprise specific measures are taken by the Government to improve the performance of the PSUs. Some of these include periodical review of performance of PSUs, grant of operational freedom, professionalisation of PSU boards, technology upgradation, diversification and change of product mix, modernisation of plant and machineries, inventory and cost control, business and financial restructuring, rationalisation of manpower, etc.

Revival of Sick PSEs

- 41. SHRI RAJNATH SINGH 'SURYA': Will the Minister HEAVY INDUSRIES AND PUBLIC ENTERPRISES be pleased to state:
- (a) whether it is a fact that most of the PSEs in his Ministry are either sick or loss making.
 - (b) if so, details of such PSEs, the category-wisse;
- (c) how many of them have been recommended each for revival and for winding up; and

(d) the details of revival plan for sick PSEs-, if any?

THE MINISTER OF STATE IN THE MINISTRY OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (DR. VALLABH BHAI RAMJI BHAI KATHIRIA): (a) and (b) Out of 48 operating PSEs under the administrative control of this Department, 16 PSEs made profit and 32 made loss in 1998-99. 26 PSUs are sick and referred to Board for Industrial and Financial Reconstruction (BIFR)

(c) and (d) Revival plans have been sanctioned by BIFR in case of 11 PSEs involving fresh infusion of funds to the extent of Rs. 616 Cr. and financial restructuring of Rs. 2063 Cr. as per unit-wise details given in the Statement *[see* below). In case of 8 PSEs. BIFR at one stage or the other reached the conclusion that company was non-viable and expressed preliminary/final view regarding winding up. Disinvestment Commission have recommended discontinuance of operations in case of Rehabilitation Industries Corporation Ltd. (RIC). An Expert group has been constituted by the Government to examine the possibility of revival of some of these PSUs. BIFR has since sanctioned and circulated the revival scheme in case of National Instruements Ltd. (NIL) on 15.11.1999.
