Governments. As per the oil industry practice throughout the country, a maximum allocation of 250 KL of Kerosene per month per block dealership is made. New dealerships are created by restructuring the existing dealerships selling more than 250 KL of Kerosene per month. Any additional allocations above 250 KL is distributed to the dealerships whose allocation is less than 75 KL per month.

- (a) whether it is a fact that there is no petrol pump at Tehsil hcadequarter of Bhikiyasain in Almora district of Uttar Pradesh; if so, the reasons therefor;
- (b) whether Kumapn Mandal Vikas Nigam has assessed or propose to assess the requirement of Bhikiyasain Tehsil headquarter and its adjoining areas such Janala, Bhatraujkhan, Basot, Machhour, Sadar, Masi, etc. in order to open petrol pump there; and

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) Retail Outler dealerships are opened at locations meeting Oil Industry's viability norms. Location Bhikiyasain has not been found feasible for setting up retail outlet dealership.

(b) Government is not aware about any such survey conducted or propose to be conducted by Kumaon Mandal Vikas Nigam.

## **Corruption in Petrol Pumps**

1040. SHRI RAHASBIHARI BARIK: Wirt the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- the (a) whether attention Government have been drawn to the news-item captioned "Petrol Pump par Upri Kamai May Malik Ka Bhi Hissa" appeared in the Navbharat Times dated the 31st January, 1999;
  - (b) if so, the details thereof;
- (c) the reaction of Government thereto: and
- (d) the action taken by Government so far in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) and (b) Yes Sir. No such instances have come to the notice of the Government.

(c) and (d) Regular inspections/ surprise checks of retail outlets are carried out by the officers of the oil marketing companies. Also special drives are lunched by the industry from time to time for checking malpractices including adulteration.

## Refining capacity in the country

- 1041. SHRI SURYABHAN PATIL VAHADANE: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:
- (a) what is the refining capacity in India as on 31st December, 1998;
- (b) which oil refineries in India arc using the indigenous crude from the Assam Oil Fields;
- (c) whether the attention of Government have been drawn to the ban imposed by ULFA on Oil Transport from Assam:
- (d) what is the reaction of Government thereto; and
- (e) whether Government have decided to increase the quantity of imported crude in 1998-99?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) Petroleum Sector has been delicensed from June, 1998. As a result, now oil companies are free to maintain their installed capacities flexible depending on demand/supply scenario.

- (b) The indigenous crude from the Assam Oil Fields is being used by Digboi, Guwahati, Bongaigaon Barauni Refineries.
- (c) and (d) Oil PSUs have been advised to take necessary action to strengthen the security.
- (e) The quantity of crude oil imported during the last 3 years were as follows:-

1996-97	33.90
1997-98	34.49

As per the Oil Economy Budget (R.E.) for 1998-99, the quantity of crude oil likley to be imported is to the tune of 35.226 MMT.

#### Private Agencies in Oil Fields

- (a) whether attention of Government has been drawn to the news-item appearing in the Economic Times dated 13th February, 1999 under the caption "Private oil fields gushing Government blocks contracts"; and
- (b) if so, what is Government's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) and (b) Due to certain observations made by the CAG on the award of discovered fields for private participation, the policy is under review.

## Foreign investment in Oil Refineries

- 1043. SHRI SURESH KALMADI: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:
- (a) whether it is a fact Government propose to attract more foreign investment in oil refineries; and
- (b) if so, what are the salient features of the proposal?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) and (b) Yes. Sir. The present gudelines for issue of LOIs for setting up of the refineries are as under:-

- (i) In the refinery sector in Domestic Tariff Area (DTA), refineries where JV with PSUs Foreign Direct Investment (FDI) has been limited to 26% (PSU 26% and balance 48% public equity) and where the JV partner is a private Indian Company, FDI has been limited to 49% of total equity.
- (ii) For EOU refineries 100% FDI is permitted.
