Declaration of Assets by Ministers

- (a) whether it is a fact that when the new Government took over in March last year the Union Cabinet had decided that Ministers should file statements regarding their assets and liabilities to the Prime Minister within 90 days, for being made public;
- (b) if so, the number of Ministers who have filed/sent statements and the steps taken to publicise them; and
- (c) the names of Ministers who have not filed their statements so far and what steps are proposed to be taken to make them fall in line?
- THE MINISTER OF HOME AFFAIRS (SHRI L.K. ADVANI): (a) to (c) All the Members of the Union Council of Ministers had declared their

assets and liabilities to the Prime Minister However, since the returns submitted by the Ministers were in different formats, the Prime Minister has written to his Cabinet colleagues to submit their returns, as on 31.3.98, in the prescribed pro forma, so that a copy of each of the returns may be placed in the Parliament Library.

Decision Regarding Chandigarh

- 827. SHRI KARTAR SINGH DUGGAL: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether the decision regarding Chandigarh has been hanging fire all these days; and
- (b) if so, the steps Government contemplate to take to settle the issue to the satisfaction of the parties concerned?
