- (a) whether it is a fact that Union Government had accepted the Fifth Central Pay Commission's recommendation that the husband and wife be posted invariably at the same station, to lead a normal life;
- (b) if so, whether it is a fact that couples serving in Kendriya Vidyalayas and their spouses serving therein have been separated or not brought together during 2000-2001;
  - (c) if so, the details of such employees; and
  - (d) the reasons and justification therefor?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (DR. MURLI MANOHAR JOSHI): (a) The Fifth Central Pay Commission did not make any specific recommendation to the effect that the husband and wife be posted invariably at the same station.

However, as a matter of abundant precaution, the Board decided that a small group of Board members may reexamine the proposals to ensure that the instructions of DoPT are followed within a period of one month and submit them to the Chairman for approval.

### Empowering of women

1556. SHRI R.S. GAVAI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether Government are making efforts towards empowering women;
  - (b) if so, the details of action taken/progress made in this regard;
  - (c) whether Government have a time bound programme; and
  - (d) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI SUMITRA MAHAJAN): (a) and (b) The Government has been formulating various strategies and interventions for the empowerment of women. These include:

- (i) The 73rd and 74<sup>th</sup> Constitutional amendments which brought about a definite impact on the participation of women in the democratic institutions at the grass root levels through the Panchayati Raj Institutions and local bodies.
- (ii) There are many schemes of various Ministries/Departments for capacity building and economic empowerment of women. These include the schemes such as Support to Training and Employment Programme (STEP), Setting up of Employment-cum-Income Generation-cum-Production Units (NORAD), Socio Economic Programme (SEP), Rashtriya Mahila Kosh and Swa-shakti which are implemented by the Department of Women and Child Development.
