Outcome of Indo-Pak Talks on Tulbul **Navigation Project**

1079. SHRI RAGHAVJI: PROF. VIJAY KUMAR MALHOTRA:

(a) what are the details of the talks held recently between India and Pakistan on Tulbul Navigation Project; and

(b) whether differences between the two countries on this issue have been narrowed down, if so, the details in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND MINISTER OF STATE IN THE MINIS-TRY OF WATER RESOURCES (SHRI SOMPAL): (a) and (b). During discussions held on 5.11.1998 between India and Pakistan on Tulbal Navigation Project as part of the composite dialogue process, both sides exchanged views and took note of the previous discussions from October 1987 to August 1992 on technical and legal aspects related to the project. India drew Pakistan's attention to the understandings reached in 1991 at Secretary level discussions. Pakistan however, denied that any understanding was reached in the past in respect of this project. The Indian side informed Pakistan that the proposed project was designed to regulate the flow of waters from the Wular Lake for navigational purposes and it did not involve any consumptive use and was fully consistent with the provisions of the Indus Waters Treaty. It was also agreed that discussions on the project would continue during the next round of talks under composite dialogue

Search for Lost Saraswati River

- 1080. SHRI SANTOSH BAGRODIA: Will the PRIME MINISTER be pleased to state:
- (a) whether Government plan to have a project initiated to search for lost Saraswati river in the State of Rajasthan;
- (b) if so, how and when Government plan to take up this initiative; and

(b) The Ministry has initiated work for searching the palaeo drainage network in Western Rajasthan also referred to as the lost Saraswati River. The Central-Ground Water Board has been entrusted with this responsibility during 1998-99. The Board 211

is collaborating with the Ground Water Department, Rajasthan, Bhaba Atomic Research Centre (BARC), Mumbai, Regional Remote Sensing Application Centre, Jodhpur and Physical Research Laboratory, Ahmedabad, for this purpose. The studies include remote sensing, geophysical survey, hydro-geological mapping, isotopic studies, test drilling as well as literature Survey.

Technical Approval for Bakroi Project in Gujarat

During 1996-97 Government of U.P. was approved CLA of Rs. 67 crores for six projects of which only Rs. 43.50 crores could be released as the state submitted in time utilisation certificate in respect of only two projects for availing second instalment. Due to reduction in funds under AIBP at Revised Estimate state, the State could be released only part payment of second instalment even for these two projects.
