Decline in Cultivation

943, SHRI RAJNATH SINGH 'SURYA': Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that the total area under cultivation is coming down in the country;
 - (b) if so, the reasons therefor;
- (c) whether repeal of ULCRA will encourage construction on agricultural land; and
- (d) whether any study has been done in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI SOMPAL): (a) and (b) The total cultivated area (net sown area + current fallows) in the country has, more or less, remained constant at around 156 million hectares.

- (c) The land which is mainly used for agricultural purposes was not deemed to be urban land and did not come under purview of the Act vide Section 2(o) and Explanation (c) under Section 2(o) of the Urban land (Ceiling & Regulation) Act, 1976. The repeal of the Act is not, therefore, likely to have any implication on agricultural land.
 - (d) No study was conducted.

Efforts to Increase Food Production

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI SOMPAL): Department of Agriculture and Co-operation is Implementing a number of crop oriented

production programmes covering rice, wheat, coarse cereals, sugarcane, oilseeds, pulses and cotton. For gearing up the financial sector for more funds for agricultural sector, Kisan Credit Card Scheme has been launched by all public sector banks besides introduction of at least one specialised agricultural bank in each state to cater to the needs of high tech agriculture.

Assistance to U.P. and Bihar from National Calamity Fund

THE MINISTER OF STATE IN THE AGRICULTURE MINISTRY OF (SHRI SOMPAL): (a) to (d) During 1998-99, the Government of Bihar had requested for assistance of Rs. 1003.75 crore from the National Fund for Calamity Relief (NFCR) in the wake of floods, and the Government of Uttar Pradesh had requested for assistance of Rs. 2139.49 crore from the NFCR in the wake of floods/landlides. The requestes are at various stages of process in accordance with the established procedure for assistance from the NFCR.
