#### **Disinvestment in BRPL**

1024. DR. ARUN KUMAR SARMA: Will the Minister of PETROLEUM AND NATURAL GAS be -pleased to state:

(a) the status of proposed disinvestment of Bongaigaon Refinery and Petrochemical Ltd. (BRPL) in Assam;

(b) whether ICICI has submitted its report on disinvestment of BRPL;

(c) if so, the salient features and reaction of Government thereto; and

(d) whether Government would consider exclusion of BRPL from disinvestment in line with the report of ICICI?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) to (d) Government had approved the appointment of an Adviser to examine all alternatives and options including those recommended by the Disinvestment Commission. The recommendation of BRPL Board on the Report of Adviser has been received. The report of Adviser broadly covers aspects such as financial analysis, marketing of products, future business

-scenario and strategic alliance opportunities for BRPL.

The Government has meanwhile, appointed a Committee to *inter-alia*, study and assess the viability and prospects of stand alone marketing companies and stand alone refineries including the BRPL.
