## **Appointment of Governors**

845. SHRI ANANTA SETHI: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government propose to fill up the vacancies of Governor in some States:
- (b) if so, the steps taken in this regard; and
- (c) the reasons for delay in appointment of Governors in the States where acting Governors are appointed?

THE MINISTER OF HOME AFFAIRS (SHRI L. K. ADVANI): (a) to (c) Two Governors have completed five years, which is the normal term of office of a Governor. However, according to the proviso to article 156(3) of the Constitution of India, a Governor shall, notwithstanding the expiration of his term, continue to hold office until his successor enters upon his office.

In addition to the above, the Chief Justice of Gujarat has been discharging the functions of Governor of Gujarat since 16.1.1999.

The question of making fresh appointments of Governors is under consideration.
