Eradication of T.B.

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMI-LY WELFARE (SHRI DALIT EZHIL-MALAI): (a) to (c) To control TB, National TB Control Programme was launched in 1962. Since this programme did not have the desired effect, a revised strategy with the objective of achieving

85% cure rate of smear positive patients and detecting at least 70% of them was evolved and pilot teste in two phases. The Revised National Tuberculosis Control Programme (RNTCP) was lauched in 1997 with World Bank assistance. The RNTCP is being implemented in 102 Districts covering a population of 171.2 million in phases for a period of 5 years. The strategy includes diagnosis through quality sputum microscopy and treatment by Short Course Chemotherapy under direct observation. About 8 out of 10 patients are being cured as compared to about 3 out of 10 completing the treatment in the earlier programme. Service delivery in majority of 39 1st year districts covering a population of 100 million has already started. Preparatory activities in 39 IInd year districts have also started.
